**Share Repurchase Program Update**

SHENZHEN, PRC – November 24, 2014 – Nam Tai Property Inc. (“Nam Tai” or the “Company”) (NYSE Symbol: NTP) today reminds its shareholders that while its share repurchase program is scheduled to terminate on November 30, 2014, since November 29 and November 30 are Saturday and Sunday, respectively, and no trading may be completed during those dates, Nam Tai will effectively close its share repurchase program at the close of business on Friday, November 28, 2014.
